# Election of members of the new Supervisory Board of Deutsche Börse Aktiengesellschaft 2015

---

Proposal for the election of Supervisory Board members representing the shareholders

## Election of members of the new Supervisory Board

The term of office of all Supervisory Board members elected by the Annual General Meeting will expire at the end of the Annual General Meeting on 13 May 2015.

The last Annual General Meeting held on 15 May 2014 had resolved to reduce the size of the Supervisory Board of Deutsche Börse Aktiengesellschaft starting with the next regular term of office and to amend section 9 (1) of the Articles of Association of Deutsche Börse Aktiengesellschaft accordingly. Therefore, section 9 (1) sentences 1 and 2 of the Articles of Association of Deutsche Börse Aktiengesellschaft stipulates that the Supervisory Board shall comprise 18 members up until the close of the Annual General Meeting in 2015 and at such time the term of office of all Supervisory Board members shall routinely end in accordance with the law and the Articles of Association; after such time, the Supervisory Board shall comprise only 12 members.

Accordingly, pursuant to sections 96 (1), 101 (1) of the Aktiengesetz (German Stock Corporation Act) and sections 4 (1), 1 (1) no. 1 of the Drittelbeteiligungsgesetz (German One-Third Employee Representation Act) and section 9 (1) sentences 1 and 2 of the Articles of Association of Deutsche Börse Aktiengesellschaft, the Supervisory Board consists of 12 members, comprising 8 shareholder representatives and 4 employee representatives. Nominations for the election of shareholder representatives are not binding on the Annual General Meeting.

The Supervisory Board proposes the election of the following persons as shareholder representatives to the Supervisory Board, to be voted on individually.
